\* 11/18/2024 sale of 12.5 acres to Project Acre for \$100,000

\* Two new commissioners that collaborated with Yanceyville Industrial Park construction in the 1990s at no cost to taxpayers. Perhaps these efforts can be duplicated in Pelham as shell buildings have been proposed twice, albeit with a \$500,000 price tag requested (this council in 11/2022 and Economic Development budget in 5/2024).

\* Economic Developer position is on hold with consideration to combine with the future County Manager's role.

\* Economic development website is essentially unchanged for 5 years and Co-Square vision has diminished with expansion of broadband in the county. The anchor tenant, Mesur.io never showed up except for a sign on the door. Surrounding counties focus on site plans, workforce, available loans, technical assistance, training resources, DOT plans and basic infrastructure.

\* As noted by the International Economic Development council in Feb. 2022, tourism, green space, trail systems, game lands, Farmer's Market, NC Extension & CEAD's focus on agri-business appear to offer the economic greatest potential moving forward into 2025.
